#### **SECTION 3 - HAZARDS IDENTIFICATION**

WARNING! Causes substantial but temporary eye injury. Do not get in eyes. Harmful if absorbed through skin or if swallowed. Avoid contact with skin or clothing.

#### **SECTION 4 - FIRST AID MEASURES**

If poisoning occurs, immediately contact a doctor or Poisons Information Centre, and follow the advice given. Show this Material Safety Data Sheet to the doctor.

If swallowed: Call a poison control center or doctor immediately for treatment advice.

Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

##### **Note to physician:**

Early signs of intoxication include dilation of pupils, muscular in coordination, and muscular tremors. Toxicity following accidental ingestion of the technical product can be minimized by vomiting within one-half hour of exposure; rapidly after exposure (<15 minutes) administer repeatedly medical charcoal in a large quantity of water or ipecac.

If toxicity from exposure has progresses to cause severe vomiting, the extent of resultant fluid and electrolyte imbalance should be gauged. Appropriate supportive parenteral fluid replacement therapy should be given, along with other required supportive measures (such as maintenance of blood pressure levels and proper respiratory functionality) as indicated by clinical

signs, symptoms, and measurements.

In severe cases, observations should continue for at least several days until clinical condition is stable and normal. Since abamectin is believed to enhance GABA activity in animals, it is probably wise to avoid drugs that enhance GABA activity (barbiturates, benzodiazepines, valproic acid) in patients with potentially toxic abamectin exposure.

### Unusual Fire, Explosion and Reactivity Hazards

Can release vapors that form explosive mixtures at temperatures at or above the flash point. Heavy vapors can flow along surfaces to distant ignition sources and flash back. During a fire, irritating and possibly toxic gases may be generated by thermal decomposition or combustion.

### In Case of Fire

Use appropriate extinguishing media for combustibles in the area. Wear full protective clothing and self-contained breathing apparatus. Evacuate nonessential personnel from the area to prevent human exposure to fire, smoke, fumes or products of combustion. Prevent use of contaminated buildings, area, and equipment until decontaminated. Water runoff can cause environmental damage. If water is used to fight fire, dike and collect runoff.

## **SECTION 6 - ACCIDENTAL RELEASE MEASURES**

### In Case of Spill or Leak

Control the spill at its source. Contain the spill to prevent from spreading or contaminating soil or from entering sewage and drainage systems or any body of water. Clean up spills immediately, observing precautions outlined in Section 8. Cover entire spill with absorbing material and place into compatible disposal container. Scrub area with hard water detergent (e.g. commercial products such as Tide, Joy, Spic and Span). Pick up wash liquid with additional absorbent and place into compatible disposal container. Once all material is cleaned up and placed in a disposal container, seal container and arrange for disposition

## **SECTION 7- HANDLING AND STORAGE**

Store the material in a well-ventilated, secure area out of reach of children and domestic animals. Do not store food, beverages or tobacco products in the storage area. Prevent eating, drinking, tobacco use, and cosmetic application in areas where there is a potential for exposure to the material. Wash thoroughly with soap and water after handling.
