## 2. HAZARDS IDENTIFICATION SUMMARY

**KEEP OUT OF REACH OF CHILDREN – CAUTION** – Harmful if swallowed, absorbed through skin, or inhaled. Avoid breathing dust. Causes eye irritation. Avoid contact with eyes, skin or clothing.

This product is a gray to tan to light brown granule with virtually no odor.

## 4. FIRST AID MEASURES

**If swallowed:** Call a poison control center or doctor immediately for treatment advice. Have a person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.

**If inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.

**If on skin or clothing:** Take off contaminated clothing. Rinse skin with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

**If in eyes:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing the eye. Call a poison control center or doctor for treatment advice.

**NOTE TO PHYSICIAN:** There is no specific antidote for Atrazine. If this product is ingested, induce emesis or lavage stomach. The use of an aqueous slurry of activated charcoal may be considered.

## 5. FIRE FIGHTING MEASURES

**FLASH POINT (°F/Test Method):** Does not flash.  
**FLAMMABLE LIMITS (LFL & UFL):** None established  
**EXTINGUISHING MEDIA:** Considered non-combustible, use medium appropriate to surrounding fire. Dry chemical, carbon dioxide, foam, water spray or fog.  
**HAZARDOUS COMBUSTION PRODUCTS:** HCN, oxides of nitrogen, acetonitrile, chlorine-containing compounds and other unknown hazardous material may be formed in a fire situation.  
**SPECIAL FIRE FIGHTING PROCEDURES:** Wear self-contained breathing apparatus with full protective clothing.  
**UNUSUAL FIRE AND EXPLOSION HAZARDS:** If water is used to fight fire, contain runoff, using dikes to prevent contamination of water supplies.

## 6. ACCIDENTAL RELEASE MEASURES

### STEPS TO BE TAKEN IF MATERIAL IS RELEASED OR SPILLED:

Control the spill at its source. Sweep up material and place in a container for possible land application according to label use or for proper disposal. Check local, state and federal regulations for proper disposal.

**CAUTION:** Keep spills and cleaning runoff out of municipal sewers and open bodies of water.

## 7. HANDLING AND STORAGE

**HANDLING:** Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Remove clothing immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing. Remove PPE immediately after handling this product. Wash the outside of gloves before removing. As soon as possible, wash thoroughly and change into clean clothing.  
**STORAGE:** Store in a safe manner. Store in original container only. Store in a cool, dry place. Do not contaminate water, food, or feed by storage or disposal.

**Personal Protective Equipment:** **Applicators and other handlers must wear:** long sleeved shirt and long pants, chemical-resistant gloves such as Barrier Laminate, Nitrile Rubber, Neoprene Rubber or Viton®, chemical resistant footwear plus socks. **Mixers and loaders must wear:** long sleeved shirt and long pants, chemical resistant gloves such as Barrier Laminate, nitrile Rubber, Neoprene Rubber or Viton®, chemical resistant footwear plus socks, and protective eyewear. Follow manufacturer's instructions for cleaning and maintaining PPE. If no such instructions for washables, use detergent and hot water. Keep and wash PPE separately from other laundry.

## 12. ECOLOGICAL INFORMATION

Atrazine is toxic to aquatic invertebrates. For terrestrial uses, do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. Runoff and drift from treated areas may be hazardous to aquatic organisms in neighboring areas. Do not apply directly to lakes, streams, or ponds. Use with care when applying in areas adjacent to any body of water. Do not apply when weather conditions favor drift from target area. Do not contaminate water when disposing of equipment wash waters.

## 13. DISPOSAL CONSIDERATIONS

Do not reuse product containers. Completely empty container into application equipment.
