#### Ground Application

Flat fan nozzles are recommended for the most uniform coverage. To maximize weed control, apply at 15-20 gallons per acre with a spray nozzle pressure of 40-60 PSI to produce a medium (300 microns) droplet size. Apply to actively growing weeds.
