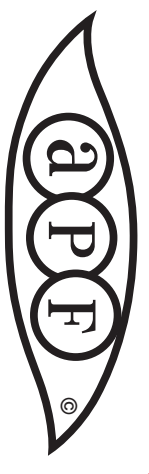

Recommendations for use and mixing rates –

Research with various crops and these herbicides has shown that weed kill has been increased when ammonium sulfate is used as an additive to the tank mix.

Only a small amount of ammonium sulfate is added to the herbicide - 8 to 20 pounds per 100 gallons of water. Agitate the tank water while slowly adding the ammonium sulfate. Allow enough time for complete dissolution before adding additional adjuvants or herbicides.

Use only sprayable grade ammonium sulfate with herbicides. Perform a jar test to check the quality of the ammonium sulfate. Add 1/3 cup of ammonium sulfate to 1 gallon of water and agitate for 1 minute. If you observe undissolved sediment, you will need to predissolve the ammonium sulfate in water and filter it before adding it to the spray tank.

FOLLOW DIRECTIONS ON HERBICIDE LABEL THOROUGHLY RINSE EQUIPMENT AFTER USE.

CAUTION

AVOID CONTACT WITH EYES AND PROLONGED CONTACT WITH SKIN. AVOID BREATHING PRODUCTS DUSTS. WASH THOROUGHLY AFTER HANDLING.
